

INFORMATION ON THE TRANSFER OF PERSONAL DATA DUE TO THE TERMINATION OF TRUST SERVICES

The public limited company “**HELLENIC EXCHANGES – ATHENS STOCK EXCHANGE S.A.**” (hereinafter referred to as “**ATHEX**” or “**Company**”), with its registered seat in Athens, at 110 Athinon Ave., postal code 104 42, contact telephone number: +30 210 33 66 800 and e-mail: protocol@athexgroup.gr and info@athexgroup.gr, in its capacity as a Qualified Trust Service Provider, hereby announces that it intends to terminate the provision of digital certificate services.

Within this context, ATHEX, which it is required to retain for seven (7) years from the expiry of the digital certificate supply agreement, shall transmit the personal data of natural persons, current subscribers to certification services and former subscribers to such services, to ADACOM, a company that is a Qualified Trust Service Provider registered in the Register of Trust Service Providers of the Hellenic Telecommunications and Post Commission, with the name «ADACOM ADVANCED INTERNET APPLICATIONS S.A.», with its registered seat at 25 Kreontos, Athens, 10442 (hereinafter «ADACOM») which will be responsible for maintaining the personal data file. This personal data includes all information submitted by individuals for the issuance of their approved certificates in accordance with the digital certificate supply agreement as governed by the relevant general terms and conditions of use, namely: name, copy of identification document, contact details (e.g., telephone number, e-mail), contract data, digital certificate metadata, applications/certificates/ solemn declarations, identification details.

ATHEX acts as a **data controller**, pursuant to General Data Protection Regulation 2016/679 (“GDPR”), until the completion of the above transfer of personal data. After the transfer, ADACOM will be the sole data controller, which will determine the purpose and means of processing personal data. The transfer will be completed by November 27, 2025, and until that date, natural persons will be able to exercise their right of access, rectification, erasure, restriction of processing, objection, and data portability either by sending a letter to the following address: Athens Exchange Group, 110 Athinon Ave., 104 42 Athens, Attn: Data Protection Officer (DPO) or by email to the Data Protection Officer (DPO) of Athens Exchange Group at the email address: dataprotectionofficer@athexgroup.gr. After this period and the transfer of the above data to ADACOM, the personal data in question will be irrevocably deleted from ATHEX’s files, and the latter will not retain any copies thereof.

After this period and the transfer of personal data, the data subjects may contact ADACOM directly at dpo@adacom.com for matters relating to the processing of their data and their rights.

The transfer of personal data is carried out in order for ATHEX to comply with Articles 8 and 12 of Decision No. 837/1B/2017 of the Hellenic Telecommunications and Post Commission.

It should be noted that personal data is transferred to ADACOM, which is based in Greece, and ATHEX will not transfer data to third countries outside the EEA.
